Dear Chairmen Saylor and Bradford:

Thank you for the opportunity to provide information on Governor Tom Wolf's proposed Fiscal Year (FY) 2021-22 budget for the Department of Human Services (DHS). As promised, I am providing additional information to answer outstanding questions at the conclusion of the hearing.

Representatives Culver and Schroeder requested an analysis of the impact of Governor Wolf's proposed minimum wage increase on child care providers. As discussed during the hearing, the impact of raising the minimum wage in FY 2021-22 to the child care assistance line item is an increase of \$90,000 state and \$90,000 federal, and child care services increases \$30.5 million federal. This increase assumes an average hourly wage of \$11.35 and did not assume a base rate increase. As the minimum wage proposal is negotiated at both the state and federal level, we will update our analysis. Additionally, Representative Culver asked if a higher demand for Child Care Works (CCW) services will create a waiting list. It is not possible to predict future demand, but as of the writing of this letter there is no waiting list for CCW services, and we have a continued opportunity to enroll children until the economy is fully open and families are returning to work in 2021-22.

Representative Topper requested information related to the 2015 Physical Health-HealthChoices contract procurement. HealthChoices procurement Request for Applications (RFA) 06-15 was issued on 9/16/2015. There were concerns regarding the evaluation criteria and after consideration, DHS willingly agreed to reissue the RFA and strengthen language around this issue. HealthChoices RFA 06-15 was reissued on 7/21/2016 and was subsequently stayed by the Commonwealth Court due to a procedural issue. Subsequently, RFA 07-19 was issued on 10/15/2019. DHS is currently working through the bid protests related to this procurement and is confident the RFA and evaluation has been and will continue to be conducted in accordance with applicable law. DHS has not retained outside counsel and has had no external litigation costs related to defending challenges to the HealthChoices procurements. Further, from a programmatic perspective, there have not been additional costs associated with the protests, the subsequent appeals and delays in implementing new agreements. The Physical Health-HealthChoices program is a


\$13 billion program and both incumbents and new entrants are disappointed when they are not selected as a result of a competitive process. We continue to renew the agreements and capitation rate setting continues to ensure the rates are actuarially sound.

The Department of General Services (DGS) has implemented changes in the procurement process to include a change to Small Diverse Business (SDB) participation. The Physical Health-HealthChoices procurement was a pilot procurement for SDB goal setting. Rather than evaluate SDB and Small Business participation as part of an evaluation, DGS and DHS set goals for SDB and Veterans Business Enterprise participation, which was determined prior to the release of the solicitation.

Representative Topper also asked why we don't just set standard rates and allow any interested managed care organization (MCO) to participate in the HealthChoices program. The number of MCOs that can maintain and operate a financially viable program in a particular geographic area is influenced by the size of the area and available membership. A statewide procurement option can look very different to an interested MCO as compared to a smaller, zone-specific procurement. The makeup of the membership an MCO can attract will impact its ability to effectively manage care, control utilization and costs, and improve health care outcomes. Further, the department is required by the federal Centers for Medicare and Medicaid Services to pay our MCOs actuarially sound rates. The HealthChoices rates are based on historical costs, demographics and utilization of services within specified geographic zones.

Representative Kinkead requested the latest data on competitive integrated employment rates for individuals with intellectual and developmental disabilities. That information is as follows:

Prior to the COVID-19 Pandemic, rates of competitive integrated employment were increasing as follows:



On September 30, 2017, there were 5,370 people enrolled with the Office of Developmental Programs (ODP) reported to have competitive integrated employment. Compared to the 7,140 people reported on December 31, 2019, there are 1,770 more people with competitive integrated employment (CIE).

The pandemic, however, has caused this trend to shift:

Representative James asked for an explanation of 'Maintenance and Coordination' in the Early Intervention (EI) budget line. Maintenance and Coordination is county base funding for the program, which is used to pay for any eligible Early Intervention services, as defined in state regulation at 55 Pa.Code § 4226.5, not otherwise funded through Medicaid or our Infants, Toddlers and Families 1915(c) waiver. As I mentioned during the hearing, the reduction in the use of this service was due to the pandemic, but costs are projected to increase as more children utilize county programs.

Representative Lawrence requested information on a 2016 announcement on North Philadelphia's Health Enterprise Zone (HEZ). Each fiscal year about \$6.7 million is allocated to help address the significant health disparities in the HEZ. Below is an example of some of the recently funded HEZ initiatives:

- \$3M for community health workers
- \$2.7M for home visiting
- \$1M for eviction prevention and affordable housing

I have included links to four press releases announcing information about and funding distributions to various HEZ projects for [2016](#), [2017](#), [2018](#) and [2019](#), as Representative Lawrence indicated he was not aware of any public announcements on this issue. Finally, the Representative had asked if the top 100 super-utilizers were identified. As I indicated during the hearing, the top 100 were never identified. One of our primary focuses in this program is to help Medical Assistance enrollees in an area of the commonwealth with some of the most significant health disparities address their social determinant of health needs, as we know these factors play a much larger role in health outcomes, and ultimately health spending, than anything that happens in the traditional health care system.

Representative Greiner requested that DHS provide Medical Assistance payments for Assisted Living Residences (ALRs). DHS analyzed the financial impact of including ALRs as a benefit under Community HealthChoices (CHC). The cost to include these services was projected in 2017 to be \$434 million in state funding. DHS continues to work with our CHC MCOs to find innovative ways to meet the housing needs of our participants, which is a requirement that is built into our agreements.

Representative Warner asked what actions DHS takes to prevent waste, fraud and abuse of our beneficiary programs in response to a 2016 Auditor General report. DHS took immediate action to address Supplemental Nutrition Assistance Program (SNAP) benefits going to the Electronic Benefits Transfer (EBT) cards of deceased persons. DHS also issued a policy to its caseworkers to immediately verify death notifications upon receipt. If all household members associated with the EBT card are deceased and if that notification is confirmed to be accurate, caseworkers are to immediately deactivate the EBT card in conjunction with its current practice of closing the case and terminating the benefits.

DHS uses a series of electronic systems that allows us to communicate with federal and commonwealth agencies to verify the information provided by applicants for and recipients of public assistance. We have robust fraud prevention and monitoring protocols to ensure that we meet the program integrity standards outlined by our federal partners. In addition, we produce an [annual report](#) to the legislature that describes our efforts in this area. We also conduct federally-mandated quality control reviews of Medical Assistance and SNAP, the Federal Nutrition Services mandated management evaluations, EBT security reviews, and Payment Error Rate Measurement (PERM) reviews. Our County Assistance Office staff also serve as our first line of defense in fraud detection. They are trained on indicators of potential fraud and are instructed to report any suspicion of fraud to Office of State Inspector General (OSIG) for investigation and engage with our program participants regularly.

Further, DHS reviews monthly transactions to monitor for suspicious EBT activity, such as specific patterns of transactions, excessive EBT card replacements, and unlawful use of benefits at establishments. When potentially suspicious activity is identified, an investigation is initiated. DHS also works very closely with the OSIG to identify any potentially fraudulent activity. The OSIG investigates potential fraud on behalf of DHS, prosecutes when fraud has been identified, and recoups overpayments.

Under federal rules, EBT cards must be operable in all 50 states and the federal government does not permit states to prevent recipients from using cards out-of-state. Over the last four years, out-of-state transactions accounted for 2.6% of all transactions, and only 0.7% of all transactions take place in non-neighboring states. The top three locations where out-of-state transactions occur are Wal-Mart, Shop Rite, and Save-A-Lot.

As a result of the steps we have taken, DHS has been recognized by the federal government as a leader in monitoring out-of-state payments. In fact, the federal government requested DHS present our fraud identification techniques at several Mid-Atlantic Regional Office conferences, including providing webinars and conference calls with individual states to assist them in developing programs similar to Pennsylvania's. While we are confident that the steps we are now taking are reasonable to monitor these types of transactions, we are always looking for ways to improve. This includes working with our federal partners to explore new techniques and resources as they become known. We also review and update our current policies and procedures accordingly.

Additionally, Representative Warner asked if authorized representatives are required to sign an acknowledgement of acceptable EBT card usage. Last session Representative Warner introduced House Bill (HB) 2179 to require such a signature and we worked with him on a process whereby authorized users are required to sign the same rights and responsibilities agreements as those who are eligible for benefits, holding all recipients and authorized users to the same standards of use. Although HB 2179 did not pass into law, in recognition of the Representative's concerns, we updated our policies to require this signature process. We have revised our Authorized Representative form (PA-1969 12/19) accordingly and have provided it for your review as Attachment A.

Representative O'Neal requested information about Select Plan for Women Family Planning Council Grants line in the Fee-for-Service model. This funding provides critical family planning services to individuals with low income. The pandemic has placed greater focus and strain on the health care system as a whole and on the need for services to low income individuals. These funds have been increased to ensure that these safety net health services are available through this crisis and into the future.

Representative Quinn requested detailed information on the Office of Children, Youth & Families' (OCYF) rollout of the Child Welfare Case Management (CWCM) system. I have included in this response a document that provides an overview of our Enterprise Case Management system, of which the CWCM system is a part, and an implementation timeline as Attachments B and C. Currently, OCYF utilizes a federated case management model that allows county functions to be supported by their own stand-alone systems while state functions are being supported by our internal database. There are six different case management systems in Pennsylvania. Prior to the COVID-19 pandemic, OCYF was engaging counties and partners in business process alignment (BPA) and user story sessions. This was put on hold for much of 2020 due to the pandemic. These sessions will begin again in April 2021. The BPA sessions involve reviewing baseline processes, discussing areas for improvement and documenting future statewide processes. The user stories are a description of different software features needed from an end user perspective and the session will involve identifying the unique user stories that exist across the various counties to make sure the new system can meet all of their needs. DHS anticipates implementation of the CWCM system will occur in FY 23-24.

Representative Hershey asked for clarification on the direct care worker (DCW) training program line item in the budget. This amount represented what DHS paid to DCWs who worked during the pandemic but were ineligible to receive Act 24 of 2020 hazard pay because of the specific wording in the law. Act 24 calculated the amount each DCW would receive based on the number of individuals who worked the third quarter of 2019, but excluded anyone who started after that date, even if they worked during the pandemic. The funding in this line ensured that all DCWs who worked during the pandemic received their appropriate payment. It is also important to note that no payments were issued to DCWs who did not work during the pandemic.

Representative Krueger asked why families were precluded from DHS benefits if they included an Unemployment Determination letter from the Department of Labor & Industry. This issue was due to the delay in reauthorizing Pandemic Unemployment Assistance (PUA) at the federal level. After the issue was identified on 12/20/2020, DHS' Office of Income Maintenance issued a policy clarification revision on 01/12/2021 to our CAOs to ensure that these determination letters were not counted as income. We only count income received; potential income is subject to reimbursement but not used to deny benefits. We have not heard of any concerns on this issue since issuing the policy clarification. We have attached the policy clarification for your review as Attachment D.

Representative DeLissio asked for the structure of regionalized rate calculations under our CCW program. The [regions](#) are aligned with the 19 already-designated Early Learning Resource Center regions and create a larger pool to more accurately represent rates across provider types licensed by DHS' Office of Child Development and Early Learning (OCDEL), rather than calculating rates by county with limited sample sizes and provider type representation.

Representative Delozier requested a list of child care providers that have closed, reopened, or opened anew. That list, organized by county, is provided with this response as Attachments E and F. In addition, the Representative asked if facilities close, are they able to reopen at a different (higher) rate. Historically, the CCW policy is to pay providers the lesser of their private pay rates or the Commonwealth's Maximum Child Care Allowance (MCCA). In 2007, all private pay rates for child care providers participating in CCW were frozen in our system for this calculation. For the years 2007-2018, providers that operated prior to 2007 were paid the lesser of their pre-2007 rates or the MCCA, regardless of whether they changed their private pay fee structure. New providers opening after 2007 could submit new rates, which more accurately reflected charges to private pay parents. Some providers closed and subsequently reopened to circumvent the freeze. In 2018, the frozen MCCA rates were lifted and CCW was reimbursed to the lesser of the MCCA or their current private pay rate. OCDEL used \$19 million of the federal funding to bring all providers to a level playing field. Currently the only payment differences are between rates approved in each ELRC region by care level. The charts are available at [CCW Rates effective 3-1-2021 by Region.pdf \(pa.gov\)](#).

Representative Delozier also asked about the implementation in Pennsylvania of the congregate care provisions of the Family First Prevention Services Act (FFPSA). It is important to note that just because a territory/tribe/state submitted a prevention plan, or has an approved prevention plan, does not mean the state has the infrastructure in place to

draw down prevention dollars. Some states chose to opt-in early and then build their infrastructure. Pennsylvania chose to delay opt-in so that the infrastructure could be built prior to submitting the plan. By delaying the date for the congregate care provision of FFPSA, Pennsylvania delayed the loss of funding associated with eligible youth placed in congregate care settings. In addition, the infrastructure needed to draw down the optional Title IV-E prevention funding made available when the congregate care funding limitations take place has been established. Choosing to implement the funding limitation for congregate care earlier than our ability to claim the prevention funding would result in an even greater loss of federal funds. It may be helpful to review the Independent Fiscal Office's [report](#) on this topic. We have been in constant discussion with counties and are happy to offer technical assistance to any county that wishes to discuss challenges for implementation. Below is additional information, as requested by the Representative.

Finally, while responding to Chairman Bradford's questions regarding the line items that were underfunded for FY 2020-21, we indicated the Medical Assistance Capitation and Fee-For-Service programs were each underfunded by \$150 million. To clarify, these are the two largest areas with need in the supplemental, but the line items that were underfunded in the prior budget were Medical Assistance Capitation and Community HealthChoices.

I understand I may not:

- Trade, sell, or buy EBT card or SNAP benefits; use SNAP benefits to buy and dump food containers to receive deposits; buy things not covered by SNAP, such as alcohol, tobacco and other non-food products; or use SNAP benefits to pay for food already received or food on credit.
- Buy a product with SNAP benefits with the intent of reselling the product for cash or consideration other than eligible food.
- Buy products purchased with SNAP benefits in exchange for cash or consideration other than eligible food.
- Use or receive SNAP benefits to buy drugs or controlled substances.
- Use or receive SNAP benefits in the sale of firearms, ammunition, or explosives.

Purpose: The Department of Human Services ("DHS") will use this information to identify, assess, and monitor authorized representatives who are using Electronic Benefits Transaction ("EBT") cards on behalf of recipients.

ECM At a Glance



What is Enterprise Case Management?

Enterprise Case Management (ECM) is a new way to provide enhanced case management for the Department of Human Services (DHS) and its business partners through the implementation of a common platform to help plan and deliver participant services for multiple DHS-supervised programs.

ECM allows for:

- Easier sharing of information among DHS Program Offices, counties, participants, and providers to enable better decision making for improved participant outcomes
- Increased ability to understand performance across programs and make continuous improvements
- Enhanced data security including expanded access to data based on participant consent to enable sharing of data beyond what is currently done
- Reduced effort and cost to maintain systems because of the use of a common platform

Positive Impacts to Participants

DHS expects that participants will experience the following benefits as a direct result of ECM:

- Improved coordination of care and service planning, because ECM will allow for greater visibility into a participant's services when they are shared across programs within ECM
- Increased ability for participants to take a more active role in the care they receive, because ECM will allow participants to see their information in near-real time, ask questions, provide information, or view information about their services and supports
- Enhanced ability for participants to quickly respond to tasks or issues that arise, because ECM will leverage modern electronic communications
- Added ability for participants to manage their own appeals, because ECM will allow for the electronic submission, management, and monitoring of appeals
- Strengthened communication among participants, DHS, and its partners because ECM will allow all stakeholders to have access to case information in one tool

ECM Goals and Objectives

A main objective of ECM is to provide a complete picture of the services and supports participants and/or families receive through programs sponsored by multiple program offices within DHS and counties across the cases in which they are involved.

What does the ECM implementation mean for DHS and county human services organizations?

An integrated enterprise case management system can:

- Provide a more holistic view of the participants being served
- Promote effective communication among stakeholders at all levels
- Reinforce the connection DHS and the counties have with the individuals and families being supported as well as their providers

Overall benefits include:

- Improved access to complete case information
- Reduced data entry time through automation capabilities
- Reduced duplication of participant records and documentation
- Mobile capabilities that allow easy access to information and data capture in the field
- Improved ability to more quickly address changes in policy, laws, and regulations
- Online functionality for participants, families, and providers access status and other information related to their case or care plan

ECM At a Glance



ECM Scope

The ECM Platform is the structural foundation for four major DHS subsystems

- **Home & Community Services Information System (HCSIS) Replacement:** The HCSIS Replacement subsystem will serve as the enrollment and case management system for the DHS program offices, counties, and providers that support the Home and Community-Based Services programs including Medicaid waivers.
- **Child Welfare Case Management (CW CM):** The CW CM subsystem will create a single, statewide Child Welfare Case Management System for all Pennsylvania counties.
- **Hearings & Appeals:** The Hearings & Appeals subsystem will replace the collection of legacy systems DHS uses to manage appeals that fall under the jurisdiction of the Bureau of Hearings and Appeals (BHA).
- **Office of Long-Term Living (OLTL) Enrollment Services:** The OLTL Enrollment Services subsystem will be used by an Enrollment Services Entity and DHS to manage the process to assist individuals in exploring and applying for Long-Term Services and Supports (LTSS).

The ECM Platform will interface and share data with several other systems including:

- Centralized Person Management (currently MCI)
- Medicaid Management Information System (MMIS 2020, currently PROMISe™)
- Master Provider Index (MPI)
- Electronic Client Information System (eCIS)
- Resource Information and Services Enterprise (RISE PA)
- Enterprise Licensing System

Implementation Approach

The ECM implementation timeline spans multiple years and is comprised of three phases. The following describes, at a high level, the anticipated phases and timing of each.

- Phase 0 (est. 2021-2022): ECM Pegasystems Platform (upon which subsystems will be implemented)
- Phase 1 (est. 2022-2023): HCSIS Replacement, Hearings and Appeals, OLTL Enrollment Services
- Phase 2 (est. 2023-2024): Child Welfare Case Management (CW CM)

Question: Is there any guidance on the PUA that ended December 31, 2020, and the new extension?

Response By: Policy Clarification Unit/DFA/DHS/DFPPM

Date: 1/12/21

Yes. The PUA and the Pandemic Emergency Unemployment Compensation (PEUC) program were extended until March 14, 2021 and the maximum number of weeks an individual can claim coverage under UC, PUA or PEUC was expanded from 39 weeks of coverage to 50 weeks.

The COVID relief package was signed into law on December 27, 2020 and included an extension to the Coronavirus Aid, Relief, and Economic Security Act provisions for the PUA and PEUC and renewed the Federal Pandemic Unemployment Compensation (FPUC) through March 14, 2021. The approved FPUC payments are \$300 per week in addition to the calculated UC benefit. **The FPUC payments are exempt for income and resources per OPS 20-05-02 and PFS-20275-550.** The Pennsylvania (PA) Department of Labor and Industry began issuing payment the week of January 11, 2021.

The CAO should use the following guidance, OPS 20-05-02 and PFS-20275-550 regarding UC payments.

- At application, the CAO will count the UC income being received. If applicants have applied for UC benefits, reimbursement forms should be completed **for Temporary Assistance for Needy Families (TANF) applicants. Delayed UC, PUA or PEUC benefits are subject to reimbursement criteria for TANF. FPUC payments that coincide with the PUA and PEUC are delayed and should not be counted at application. See the PA Department of Labor & Industry at <https://www.uc.pa.gov/Pages/AlertDetails.aspx> for current status and ability to file claims on the PUA and PEUC payments.**

- Recipients must report the change in income on the Semi-Annual Review form or at Renewal. The CAO will take action and update income accordingly. **Reimbursement forms should be completed for TANF recipients expecting delayed UC, PUA or PEUC benefits. Reminder that Lump Sum retroactive PUA or PEUC payments are excluded as income for Supplemental Nutrition Assistance Program (SNAP) but are counted as a resource. For treatment of lump sum payments see CAH 157 Lump Sum, SNAP HB 540.42 Lump Sum Resources and MAEH 357 Lump Sum.**
- Recipients are required to report new or increased unearned income of \$50 or more. They are not required to report decreases in unearned income.

The CAO will act on all reported changes.

- If UC ended, the CAO will finalize the income keeping the following in mind;
 1. Individuals were covered under the PUA for a maximum of 39 weeks or until the week ending December 26, 2020. PUA has been extended to a maximum of 50 weeks or until March 14, 2021 **but currently there is a lapse in receipt of benefit payments.** It will end at that time regardless of how many weeks an individual may have remaining.
 2. Individuals covered under the PEUC were set to expire the week ending December 26, 2020. It has been extended until March 14, 2021 but **currently there may be is a lapse in receipt of benefit payments.**
 3. The FPUC ended on the week ending July 25, 2020. It has been renewed through March 14, 2021, and the amount reduced to \$300 per week. PA began issuing FPUC payments the week of January 11, 2021 **for individuals receiving regular UC. FPUC payments that coincide with the PUA and PEUC are delayed. There may be a lapse in receipt of benefit payments.**
 4. Also, the Lost Wages Assistance program, which provided an extra \$300 per week, closed on the week ending September 5, 2020 in PA due to the fund's depletion.
