

Testimony of Jim Fox, Chairperson Pennsylvania Parole Board House Appropriations Committee February 23, 2024

Good morning Chairman Harris, Chairman Grove, and distinguished members of the House Appropriations Committee. Thank you for the opportunity to appear before you today to discuss the Parole Board's budget request for FY 2024-25.

The Parole Board has dedicated staff and Board Members who are focused on community safety and a comprehensive parole evaluation process. As the Governor stated again this year in his budget address, we continue to be committed to ensuring that the parole process is focused on public safety in a fair and consistent manner. Before I go into the details of our budget request, I would like to update you on Parole Board activities, including the merger, and the implementation of new parole decisional guidelines that have been at the forefront of our mission.

The overall goal of our agency is to protect the residents of the Commonwealth. We are committed to our mission and incorporate the latest actuarial assessments, structured decision-making and professional judgment into all of our decisions. I personally have nearly 40 years of experience in the criminal justice system, having worked as a local police officer here in suburban Harrisburg, a federal probation officer, a police training academy director, and now with the Pennsylvania Parole Board. I also served for 5 years active duty in the United States Air Force. Our Board Members and Hearing Examiners similarly have a wealth of professional experience.

During the last fiscal year, the Parole Board interviewed 11,497 incarcerated individuals for parole consideration and granted parole to 49% of these individuals. The one-year recommitment rate of individuals released from incarceration during the 2022 calendar year was 19%. The recommitment rate between 2018 to 2020 of incarcerated individuals released was 35%.

In 2021, the General Assembly passed, and Governor Wolf signed into law, Senate Bill 411, now known as Act 59 of 2021. Act 59 formally merged the Parole Board and the Department of Corrections (DOC). With the parole supervision staff now formally under the DOC, the Parole Board has focused solely on the parole decision process and improving our efforts therein while ensuring public safety. This consolidation continues to run smoothly and has helped to streamline the agencies' work. It has kept independent the decision on whether parole is granted or denied, while helping to ensure that all staff work towards the same goal and does so under unified direction. The Board has made great strides in streamlining old policies and processes and will continue to look for ways to improve. The Governor, again in this budget request, enhances the support for individuals successfully entering the parole system.

I want to assure all members of the committee that our Parole Board votes to release people from prison only after considerable thought and thorough analysis. As we reported last year, the Pennsylvania Commission on Sentencing finalized new State Parole Guidelines that took effect last calendar year. We are pleased to report that this years-long process has finally culminated in a most effective tool for our decision makers to use moving forward. During the last year, these guidelines were implemented into a more efficient and automated process. Moving

forward, the new automated guideline will provide improved data, allowing for analysis to continually improve parole decision making.

Along with the new Parole Guidelines, starting in January 2024, the Board with the Commission also implemented new Parole Recommitment Ranges for parole violators. Implementation continues and will certainly aid in more fair and uniform outcomes.

To determine whether or not to parole someone, decision makers interview incarcerated individuals and review numerous reports and assessments, including actuarial instruments that predict the likelihood of future criminal behavior. Decision makers also consider criminal history, past parole or probation supervision history, psychological reports, prison-life behavior, vocational and educational program involvement, compliance with prescriptive programs that address criminogenic and/or addiction needs, home plans, and reintegration plans. We also consider recommendations from judges, district attorneys, and the victims themselves. In the last fiscal year, our decision makers participated in 1,057 in-person victim comments.

In 2012, the United States Supreme Court ruled in *Miller v. Alabama* that it was unconstitutional to impose mandatory sentences of life without the possibility of parole on juvenile offenders; in 2016, the Court ruled in *Montgomery v. Louisiana* that *Miller* should be applied retroactively. The Commonwealth of Pennsylvania had 521 of these "juvenile lifers" – more than any other state in the nation. Since the *Montgomery* decision, the Parole Board has worked aggressively to interview juvenile lifers resentenced as a result of these decisions. As of January 31, 2024, of the 495 juvenile lifers resentenced by the courts, 443 have been interviewed by the board and 291 have been paroled, for an overall parole rate of 66%. (Some of those resentenced have not yet reached their minimum parole eligibility date.) Only five paroled juvenile lifers have been recommitted on new criminal charges.

The Parole Board continually strives to improve its work. To become more effective in promoting community safety, we regularly monitor parolee outcomes, board decisions, and the reports and assessments available to us.

The Parole Board continues to embrace the use of technology in all aspects of our decision making and outcome measurement. This continues to lead to efficiencies that both speed up the parole and hearing processes and provide decision makers with more timely access to critical information.

For the coming year, the Parole Board is requesting funding to support mandated parole processes and cost-to-carry expenses. The requested amount will allow the agency to serve Pennsylvania's parole-eligible population and improve our parole decision process. In the current fiscal year, the budget for the Parole Board is \$12.9 million. This figure includes essential funding for the board, which includes the Hearing Examiners Office and the Records and Administration Office. In FY 2024-25 we are requesting \$13.6 million to continue to fund our essential operations.

Going forward, in addition to advancing the efforts from Act 59 of 2021, the Parole Board looks forward to continuing to implement the common-sense criminal justice reforms outlined in Pennsylvania's Justice Reinvestment Initiatives (JRI2). The Parole Board and the DOC will continue to be active participants in the Parole Homicide Review Team, which will report annually on circumstances and efforts to reduce homicides committed by persons on parole.

I am optimistic that the increased opportunities to reduce recidivism by using evidence-based practices to deter and reform criminal behavior will allow us to continue to enhance public safety. I continue to be encouraged by Governor Shapiro's leadership in this area, and share the Governor's belief that a safer, more united Pennsylvania is a better Pennsylvania.
